Recent Letter from Lou Binninger to Deputy Attorney General Counsel

RE: Government's Covid Prosecution of Randy Mitchell (Uppercut Salon) and Co-Workers

Dear Andrew,

I talked with you by phone recently. Thank you for your time to hear my concerns. I will keep this brief though I am furious about the State's Covid actions against California citizens. My father and uncle fought in WWII. I am a fourth generation Californian. My father was a small business owner who lost two businesses, one by fire and another by flood. Tragedies happen. Our family survived both losses.

However, never would I have believed that our own State would take away without compensation our ability to earn a living and afflict us with arbitrary regulations and enforce them like law. Our forefathers called it correctly, tyranny.

It's sad to think that all of your parents sacrificed so you could become attorneys to then be used to ruin the lives of hard-working citizens. Yes, we heard it before in history – "We are just doing our job."

Your administration's actions have cost the lives or well-being of many of my friends – relapse, overdose, youth suicide, bankruptcy, closed businesses, etc.

Your (the State's) actions against Randy Mitchell and his co-workers that affected more than 110 family members were due to the barbers working to cover living expenses while being labeled "nonessential." Who are the criminals and the lawbreakers here? Certainly not the barbers.

Consumer Affairs (CA) armed officers threatened single mother cosmetologists at Mitchell's shops with incarceration and with being occupationally blackballed in the state. They quit in fear. Good for you. C.S. Lewis tagged their type – "men with no chests."

CA cops arrested /detained a barber at the Wheatland Upper Cut shop in the middle of a haircut leaving the customer in the chair. They attempted to book the barber at the Yuba County jail. When jail officers refused to book the barber the CA cops left him outside the jail in Marysville.

CA's actions caused the closing of Mitchell's Roseville expansion costing Mitchell more than \$50,000. Bravo. Another notch on your belt.

CA cops tracked down Mitchell's "ex-wife" to hook-him-up over a felony warrant out of Butte County. Fortunately, she is more loyal to him than the State. You say the State is not mixing the cases against Mitchell. Come on Andrew. Will Mitchell be California's Randy Weaver / Ruby Ridge.

You don't want to admit that your agency found a dismissed gun charge out of Butte County to refile to threaten Mitchell with prison time. You sent your Deputy Attorney Brent Jex to Butte County to get the attention of District Attorney Mike Ramsey. Ramsey's years are over but he can always say he did the state a solid by legally "carpet bombing" a single father business owner. A real tough DA, Ramsey.

Let's make Mitchell pay dearly for following the Constitution rather than bowing to Gov Newsom's whims. Why don't we try a SWAT raid on Upper Cut?

The Butte County Bailiff at the last hearing agreed with local Yuba-Sutter law enforcement. Both consider the State and Butte County's actions "bullshit." Your own law enforcement family is losing faith in you.

The State's demand for Mitchell to pay them \$135,000 for investigating him is obnoxious. Do you want the citizens to hate you? To be righteous, the State owes Mitchell \$100,000 for his lost income overall and his lost investment in Roseville. Your decision to investigate, harass and bully Mitchell for nearly 4-years reflects your tone-deaf bad management and deficient morals.

People here are asking this question Andrew. They are not concerned with Upper Cut Salon. They ask why would your department ignore the death of Sara Matthews Easton who died August 16, 2015 at Adventist Hospital in Marysville? It's still an open case in your control according to local authorities who believe the husband shot her in the head.

She was one of our daughters, sisters, friends and mothers. Her husband Aaron Easton, at the time Chief of Police in Marysville, was later fired or resigned due to sexual assault charges. He now has become an attorney in Oklahoma.

Has your agency spent as much money solving her killing as Mitchell's barbering during Covid-Con? Your Governor's policies and ethics are a stench to the citizens. Can't someone in your office be righteous?
