This is a volunteer agreement and statement of understanding for all volunteers participating in PFCA

Canvassing efforts.

Statement of Volunteer:

1. I am over the age of 18 and a resident of the State of California.
2. I have no legal disabilities, affirm that I am under no duress or unusual influence and declare:
 - a. I have been trained by reading and/or oral/visual presentation on the 2024 PFCA Canvass Training Handbook,
 - b. Version 1 , and I have had the opportunity to ask questions including but not limited to information in that handbook, the Canvassing effort, and my responsibilities.
 - c. I understand that PFCA is a non-profit, non-partisan, citizen-/volunteer-staffed organization.
 - d. I have received no offer or promise of compensation of any kind for my participation.
 - e. I have been informed that, while PFCA makes a good faith effort to provide training to and track the location of volunteers engaged in PFCA efforts, PFCA neither insures, nor promises to insure or protect, nor protects against any risks that I may encounter as I participate in Canvassing efforts, and that I bear full responsibility to exercise sound judgment, be aware of my own surroundings, and ensure my own personal safety.
 - f. While conducting Voter Verification through Canvassing for/with PFCA, I will present and conduct myself in a professional, lawful manner, above reproach, to protect the reputation and credibility of both PFCA and the election integrity effort. PFCA reserves the right to conduct vetting, including background checks, of all volunteers to protect the reputation and credibility of PFCA.
 - g. I will safeguard and return all PFCA-provided materials and data/forms collected or created as part of the PFCA Canvassing effort to PFCA as directed by my County Captain or County Lead for Voter Verification, and in a timely manner.
 - h. Unless specifically requested by PFCA leadership, and only with prior agreement, I will not represent myself as a spokesperson nor answer media queries nor make statements or share PFCA materials and data with any party outside PFCA, and I will protect the privacy of fellow PFCA members by not sharing contact information or information from PFCA's Basecamp/internal communications without explicit prior coordination and permission from the PFCA Core Team. PFCA is committed to transparency and integrity in elections, and will uphold those same standards, but to ensure consistent, accurate, complete information is available and disseminated, PFCA requests all volunteer's direct media queries to PatriotForce.org.
 - i. PFCA will not share any personal information provided by volunteers to any third party outside PFCA without my prior approval, excepting that Voter Verification data collection in logs and affidavits, by nature and necessity, require that Voter Verification volunteers sign notarized statements attesting to the accuracy of the affidavits or witness statements, and those logs and Declaration Statements/ Affidavits may be provided to public officials, including submission as part of court cases.
 - j. Notify PFCA Core Team immediately of any adverse events/information which might bring discredit to PFCA and its objectives.
